C. Definitions

The following definitions apply for purposes of the payment Tier selected above:

1. “Event” means the boxing matches held on August 26, 2017, including the Preliminary Bouts and the Main Bout.
2. “Main Bout” means the boxing match held on August 26, 2017 between Floyd Mayweather Jr. and Conor McGregor. The Main Bout also includes the introductions, national anthem, and entrances of Mayweather Jr. and McGregor.
3. “Preliminary Bouts” means the boxing matches held on August 26, 2017 that preceded the “Main Bout” as part of the Event.

SECTION V - ACKNOWLEDGMENT

I have received notice of the class action Settlement in this case and I am a member of the class of persons described in the notice. I agree to release all the claims stated in Section 12.2 of the Settlement Agreement.
